CONCEALED HANDGUN PERMIT INFORMATION

ALL APPLICATIONS

- SWORN SIGNATURE **NOTARIZED** ON CONCEALED HANDGUN PERMIT APPLICATION.
- PROOF OF CLEAR CREEK COUNTY RESIDENCY (Colorado Driver's License, CO ID Card, Military Duty Orders).
- PROOF OF COLORADO CONCEALED CARRY TRAINING COURSE.
 - PROOF OF TRAINING REQUIREMENTS:
 1. Participation in organized handgun shooting competition or current military service.
 2. Proof that applicant is a certified handgun instructor at time of application.
 3. Proof of honorable discharge from US Military that reflects pistol qualifications within three years of application submittal.
 4. Proof of honorable discharge from US Military that reflects pistol qualifications within ten years preceding application submittal.
 5. Colorado law enforcement Retirement Certificate that reflects pistol qualifications within ten years preceding application submittal.
 6. Original handgun Colorado concealed carry training certificate or copy of training certificate with original signature of class instructor.

NEW INITIAL APPLICANT – APPOINTMENT REQUIRED

- APPOINTMENT REQUIRED ON FRIDAY MORNINGS 8AM – 11AM (call (303) 679-2376 to schedule)
- 21 YEARS OF AGE
- \$100.00 Cash or Check PAYABLE TO Clear Creek Sheriff's Office or Credit/Debit Card are accepted with a service fee of 2.7%
- \$52.50 **MONEY ORDER OR CASHIERS CHECK** PAYABLE TO **CBI** (for NICS Check & Fingerprints)
- SWORN SIGNATURE **NOTARIZED** ON CONCEALED HANDGUN PERMIT APPLICATION.
- PROOF OF COLORADO CONCEALED CARRY TRAINING COURSE.
 - PROOF OF TRAINING REQUIREMENTS:
 1. Participation in organized handgun shooting competition or current military service.
 2. Proof that applicant is a certified handgun instructor at time of application.
 3. Proof of honorable discharge from US Military that reflects pistol qualifications within three years of application submittal.
 4. Proof of honorable discharge from US Military that reflects pistol qualifications within ten years preceding application submittal.
 5. Colorado law enforcement Retirement Certificate that reflects pistol qualifications within ten years preceding application submittal.
 6. Original handgun Colorado concealed carry training certificate or copy of training certificate with original signature of class instructor.

RENEWAL APPLICANT – WITHIN 120 DAYS PRIOR TO EXPIRATION OF PERMIT

- \$50.00 Cash or Check PAYABLE TO Clear Creek Sheriff's Office or Credit/Debit Card are accepted with a service fee of 2.7%
- \$13.00 **MONEY ORDER OR CASHIERS CHECK** PAYABLE TO **CBI** (NICS Check)
- SWORN SIGNATURE **NOTARIZED** ON CONCEALED HANDGUN PERMIT APPLICATION.
- PROOF OF COLORADO CONCEALED CARRY TRAINING COURSE.
 - PROOF OF TRAINING REQUIREMENTS:
 1. Participation in organized handgun shooting competition or current military service.
 2. Proof that applicant is a certified handgun instructor at time of application.
 3. Proof of honorable discharge from US Military that reflects pistol qualifications within three years of application submittal.
 4. Proof of honorable discharge from US Military that reflects pistol qualifications within ten years preceding application submittal.
 5. Colorado law enforcement Retirement Certificate that reflects pistol qualifications within ten years preceding application submittal.
 6. Original handgun Colorado concealed carry training certificate or copy of training certificate with original signature of class instructor.
- NO PERMIT SHALL BE RENEWED **SIX MONTHS OR MORE AFTER ITS EXPIRATION DATE** AND THE PERMIT SHALL BE DEEMED PERMANENTLY EXPIRED. A PERSON WHOSE PERMIT HAS PERMANENTLY EXPIRED MAY REAPPLY BY SUBMITTING A NEW APPLICATION AND THE REQUIRED FEES.

TEMPORARY / EMERGENCY PERMIT

- 18 YEARS OF AGE OR OLDER
- \$87.50 Cash or Check PAYABLE TO Clear Creek Sheriff's Office or Credit/Debit Card are accepted with a service fee of 2.7%
- \$30.50 **MONEY ORDER OR CASHIERS CHECK** PAYABLE TO **CBI** (NICS & Criminal History)
- SWORN SIGNATURE **NOTARIZED** STATEMENT ON CONCEALED HANDGUN PERMIT APPLICATION.

CHANGE OF ADDRESS

WITHIN 30 DAYS AFTER A PERMITTEE CHANGES THE ADDRESS SPECIFIED ON HIS OR HER PERMIT, THE PERMITTEE SHALL NOTIFY THE ISSUING SHERIFF OF THE CHANGE BY SUBMITTING AN **ADDRESS CHANGE / PERMIT LOST OR DESTROYED FORM**.

LOST, STOLEN OR DESTROYED PERMIT

WITHIN THREE BUSINESS DAYS AFTER A PERMIT IS LOST, STOLEN OR DESTROYED, THE PERMITTEE SHALL NOTIFY THE ISSUING SHERIFF. THE LOST, STOLEN OR DESTROYED PERMIT IS AUTOMATICALLY INVALID. THE PERSON TO WHOM THE PERMIT WAS ISSUED MAY OBTAIN A DUPLICATE UPON SUBMITTAL OF A **NOTARIZED ADDRESS CHANGE / PERMIT LOST OR DESTROYED FORM** TO THE ISSUING SHERIFF, AND PAYING A FEE OF **\$15.00**.
